INFORMATION ABOUT THE CLIENT REGISTRATION FORM

A DECS Client Registration Number (DCRN) is required for all new clients who need to interact with the Department of Defence in relation to export control matters. You will need a DCRN to lodge an application to:

- export goods or supply technology
- register as an Australian Community member for the purposes of the Defence Trade Cooperation Treaty
- become an Intermediate Consignee for the purposes of the Defence Trade Cooperation Treaty
- apply for an International Import Certificate, Delivery Verification Certificate or Non Transfer and End Use Certificate
- register as a Broker
- conduct a brokering arrangement

DUPLICATE REGISTRATIONS

Defence looks for duplicate registrations by matching the Australian Business Number (ABN) or Customs Client Identification (CCID) and the Postcode. Duplicate registration records may occur where other ABNs, CCIDs or Postcodes are submitted on subsequent registration forms.

COLLECTION, USE AND DISCLOSURE OF PERSONAL INFORMATION

The personal information you provide in this registration form is being collected by the Department of Defence for the purpose of administering export control legislation including the *Customs Act 1901*, the *Defence Trade Controls Act 2012* and the *Weapons of Mass Destruction (Prevention of Proliferation) Act 1995*.

The information you provide will be used to register individuals and companies to use the Defence Export Control System (DECS). Defence may also use the information when undertaking other export control functions including compliance activities, and to contact you with information regarding export controls or the Australia-US Defence Trade Cooperation Treaty. Defence may provide some or all of the information to other Australian Government agencies involved in the administration of export control legislation including the Australian Customs and Border Protection Service, the Department of Foreign Affairs and Trade, the Department of Industry, law enforcement and intelligence agencies. In some circumstances, Defence may be required to provide some of this information to Australia's international regime partners in order to fulfil Australia's reporting and consultation responsibilities. If your registration is for the purposes of participating in the Australia-US Defence Trade Cooperation Treaty, some or all of the information in this form will be provided to the United State Government. Defence will not disclose your personal information beyond these circumstances unless authorised to do so by law.

The Department of Defence has a Defence Privacy Policy. The Defence Privacy Policy contains information on how an individual may apply for access to their personal information and how an individual may apply to have their personal information amended. The Defence Privacy Policy also contains information for individuals on how to make a privacy complaint to Defence if they consider Defence may have breached the Australian Privacy Principles. 1. Applicant Details

The Applicant Name should be entered as you want it to appear on all approvals and correspondence. For example, Defence Aviation Repairs, xTreme Electronics Pty Ltd, or Smith Pty Ltd trading as ABC Guns. Once registered with a DECS Client Registration Number (DCRN), all applications submitted will require the use of the same applicant name.

If you are registering for the Defence Trade Cooperation Treaty you must include your Australian Business Number.

For all other registrations:

- 1. If your activities will involve the export of goods and technology, which will require you to submit an Export Declaration to the Australian Customs and Border Protection Service, we require either your Australian Business Number (ABN) or Customs Client Identification (CCID). You must include the ABN or CCID that is registered with Customs and Border Protection in their Integrated Cargo System (ICS). - 2. If your activities will be limited to supplying intangible technology or brokering, and you do not have an ABN, then you should select the "ABN/CCID not required" field.

The Defence Export Control System (DECS) will advise you via email of your DCRN once this form has been accepted. You will need to quote your DCRN and Applicant Name on all applications you lodge.
